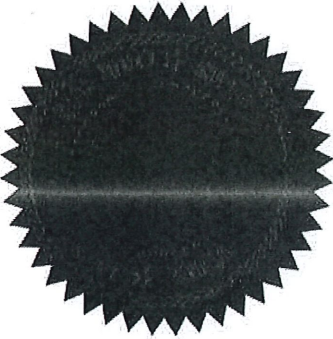

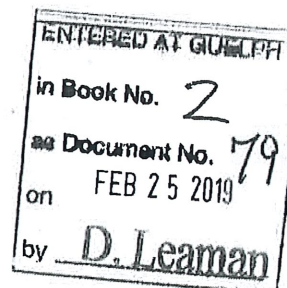
**UPON READING** the Notice of Application, Application Record, the Consent to Order, all filed, and upon hearing counsel for the Applicant, and the Respondents,

1. **THIS COURT ORDERS** that the Respondents, SERP2000 INC. and Serguei Pougatchev, be prohibited and restrained from continuing and engaging in the practice of cadastral surveying, contrary to Section 11 of the *Surveyors Act*, R.S.O. 1990, c. S.29.
  
2. **THIS COURT FURTHER ORDERS** that the Respondents SERP2000 INC. and Serguei Pougatchev, be restrained from holding themselves out to the public as engaging in the practice of cadastral surveying.
  
3. **THIS COURT FURTHER ORDERS** that leave be granted to permit the Applicant to serve a true copy of this Order on the Respondents, SERP2000 INC. and Serguei Pougatchev, by facsimile transmission and sent to Lawyers of Record for said Respondents to: Goldman Sloan Nash & Haber LLP, 480 University Ave Suite 1600, Toronto, Ontario M5G 1V2, Attn: Brian Campbell, Fax: 416.597.3370.

4. **THIS COURT FURTHER ORDERS** that the Respondents, SERP2000 INC. and Serguei Pougatchev, pay to the Applicant its costs of this Application fixed in the sum of \$2,500.00, inclusive of HST.
