
Q1 In which Regional Group are you located?







The result will be more effort to submit the plan to ODCC. Also, will plans be submitted in grid or ground format? This again could result in the need for additional work prior to forwarding to the ODCC. The \$100.00 fee should only apply if virtually no manipulation of a plan is required. It cost more to submit than the few dollars one must wait months to receive. To now embark on a new product for reference plans CAD files is brave with due regard that you do not have the participation of 100% of AOLS members. What will you do for the reference plans you are not able to get from surveyors who do not want to participate? The only way you will eventually get 100% participation is to show us the money or show us a benefit from the use of the cadastre. Perhaps free indexing of our files? Currently, there is not enough benefit to participate. Surveyors are getting older and it is not worth their while to get the current pittance for their product.
