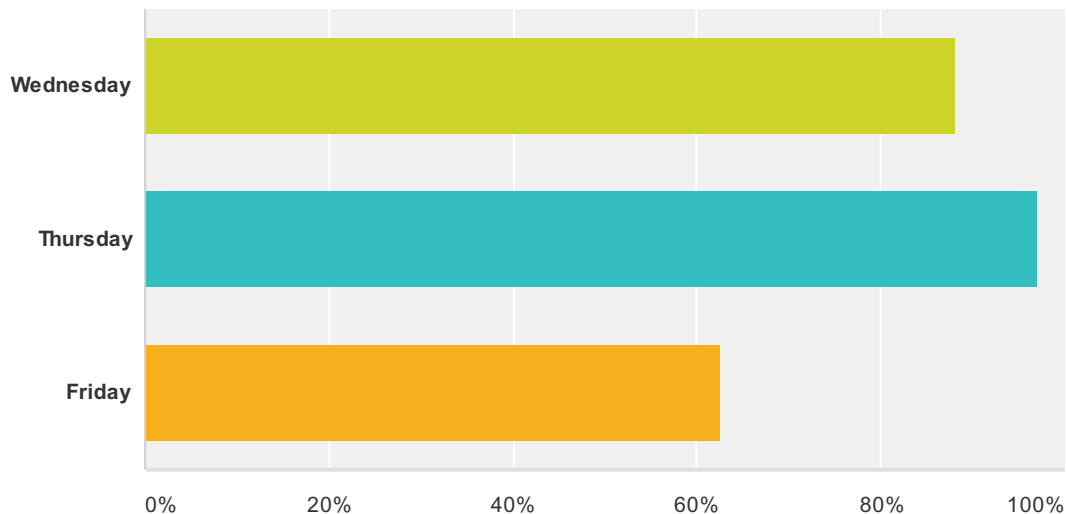

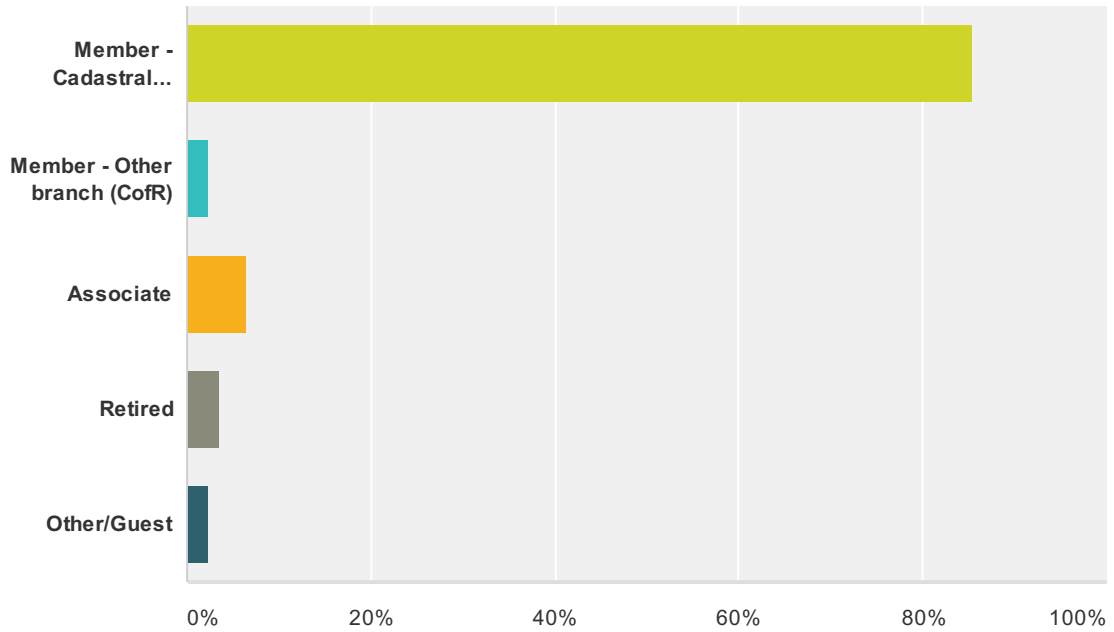

## Q2 Category of Registration for AGM

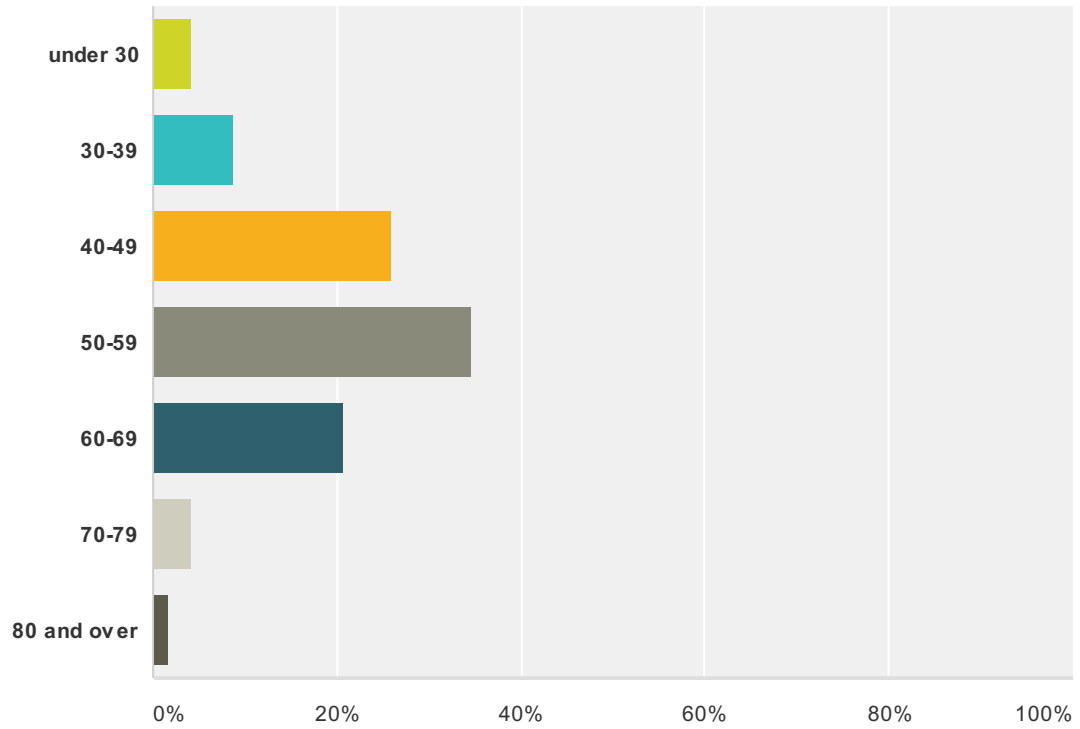

### Q3 Age

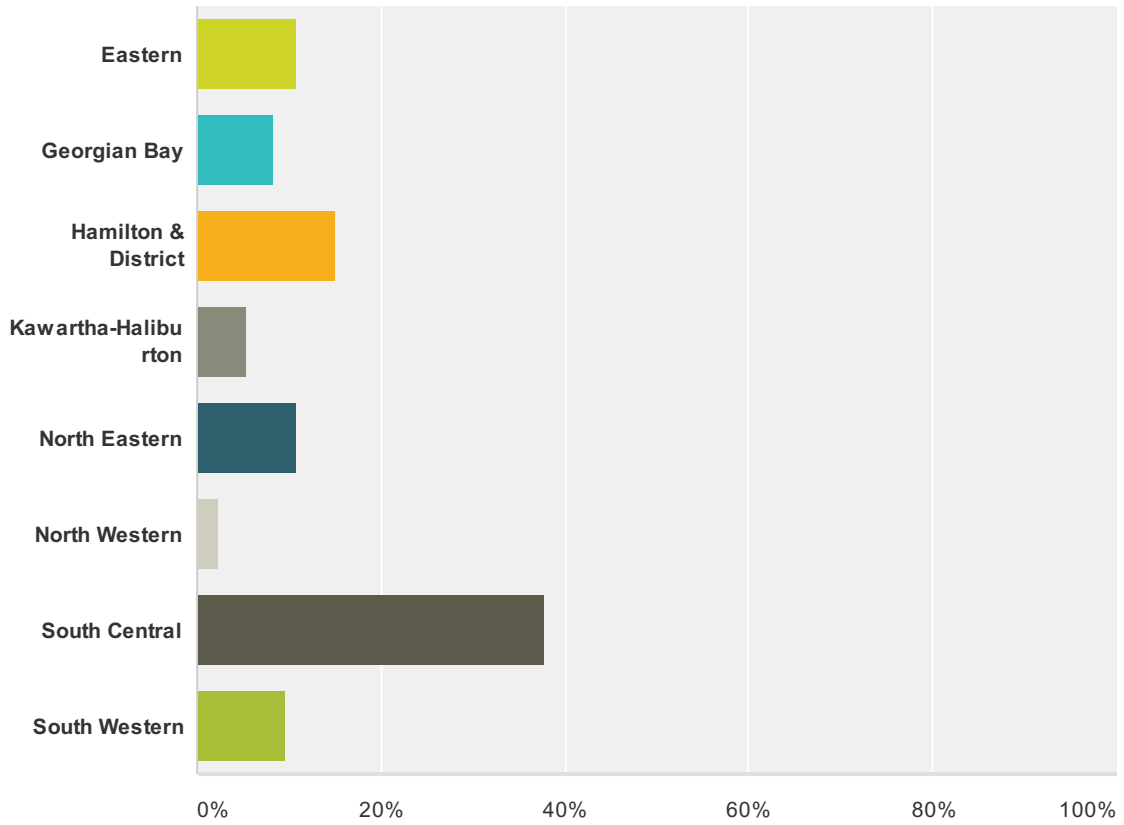

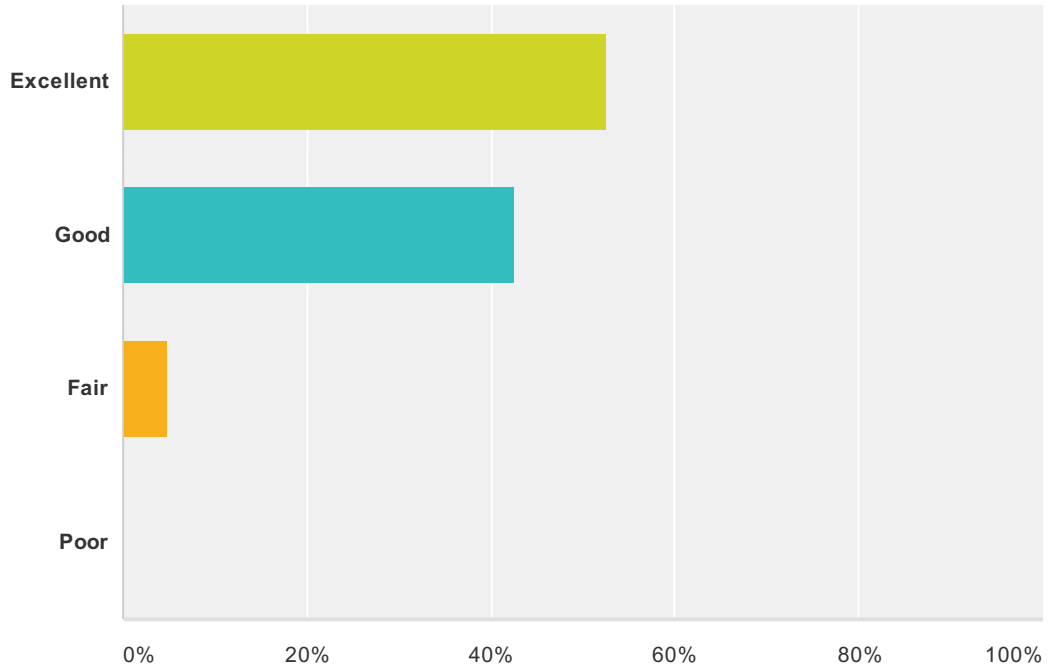

### Q5 How would you rate the conference facilities for the meeting?

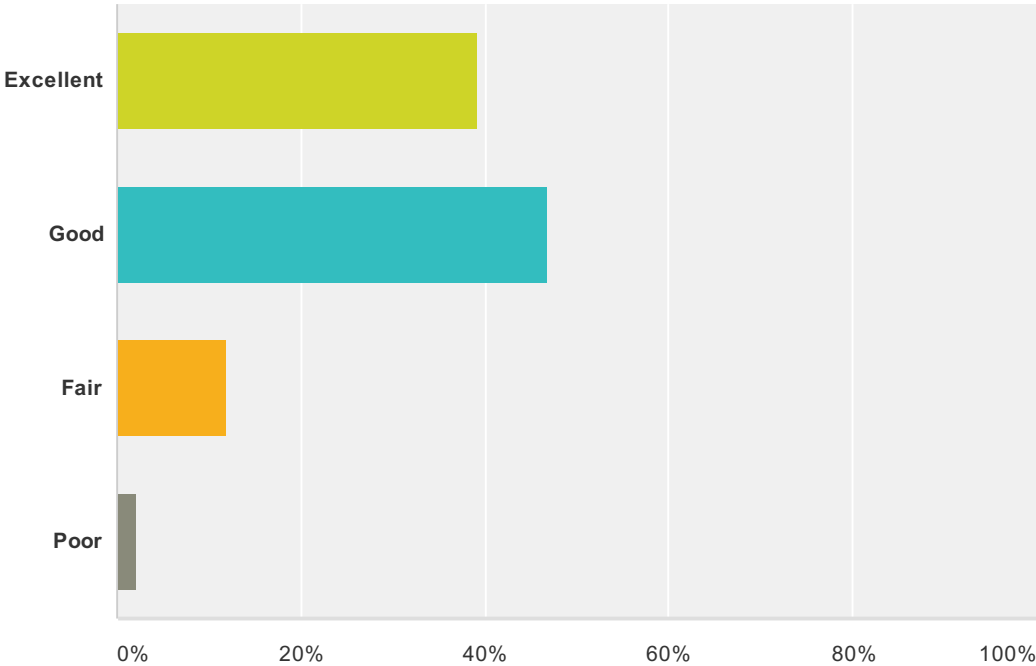

### Q6 How would you rate the meals?

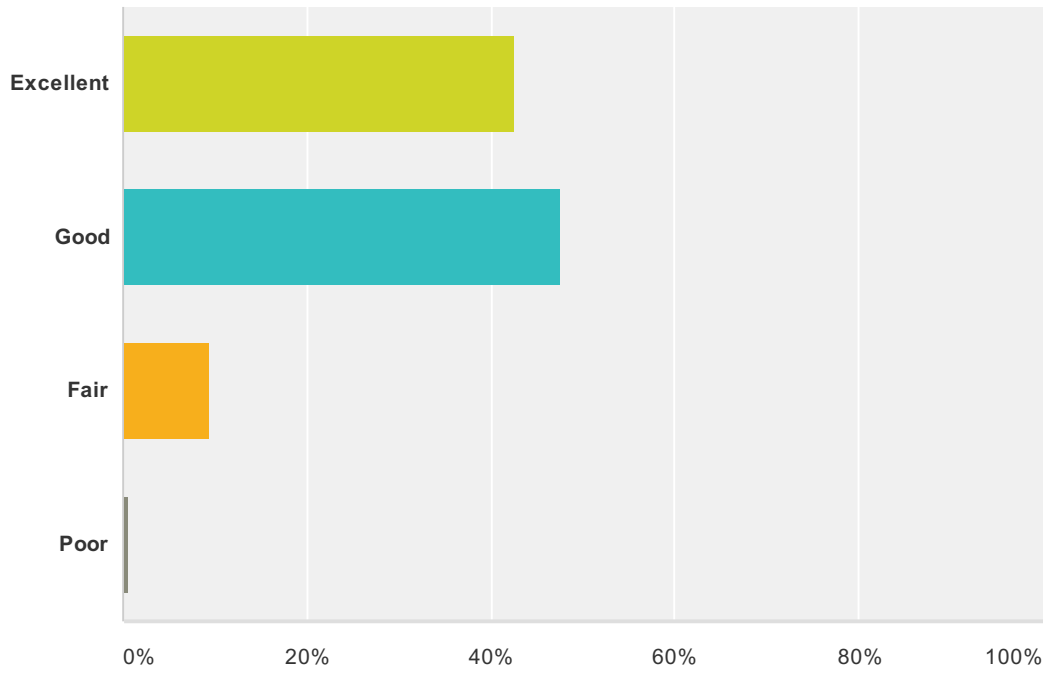

### Q7 How would you rate the meeting room for the plenary sessions?

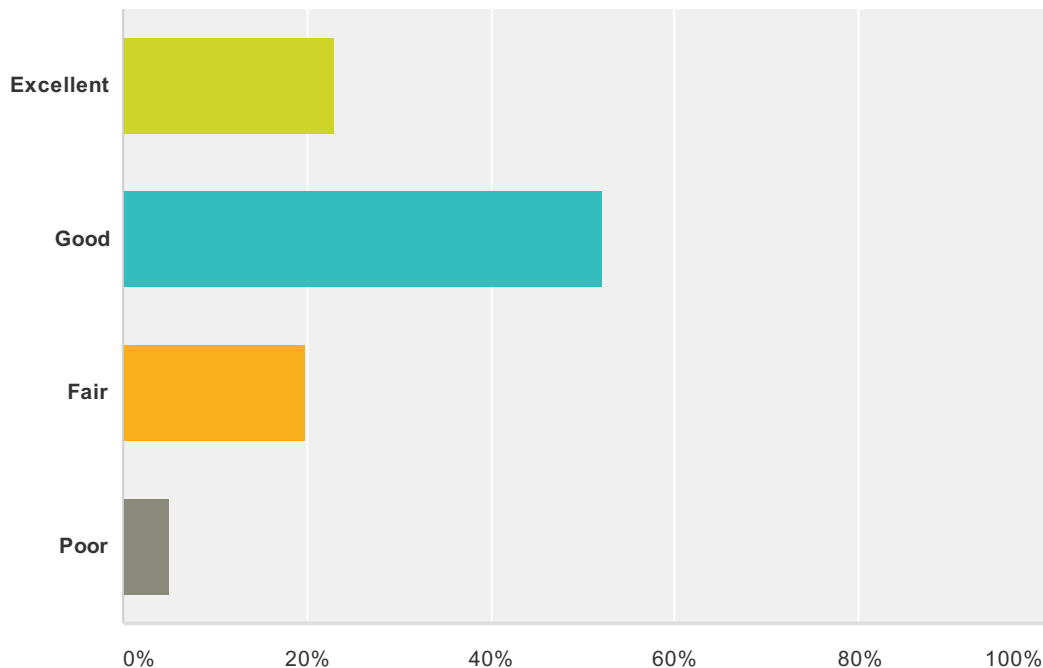

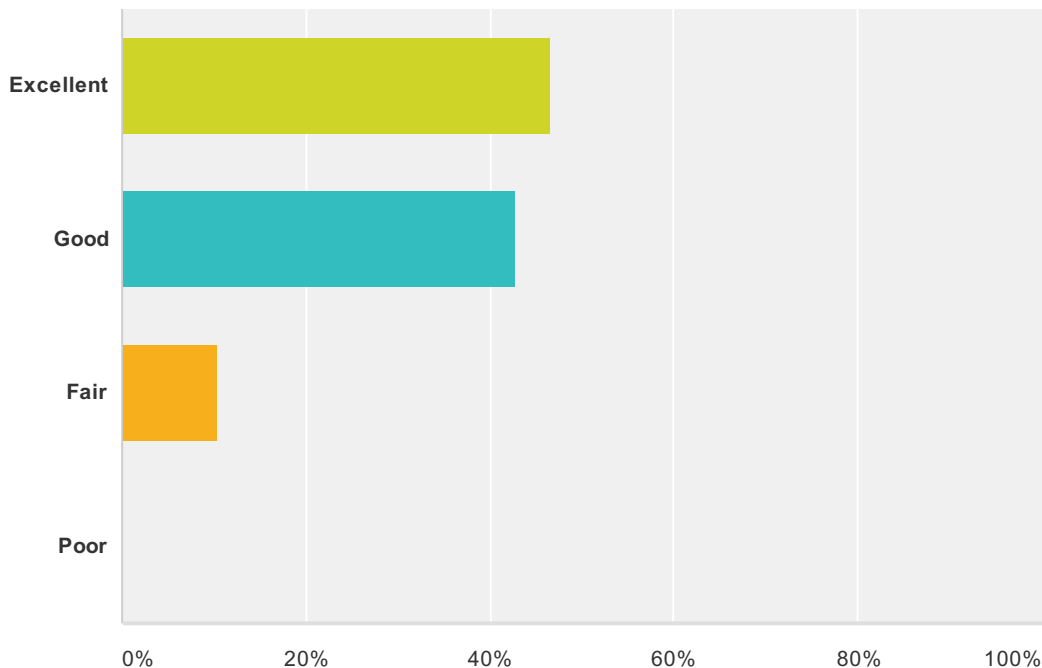

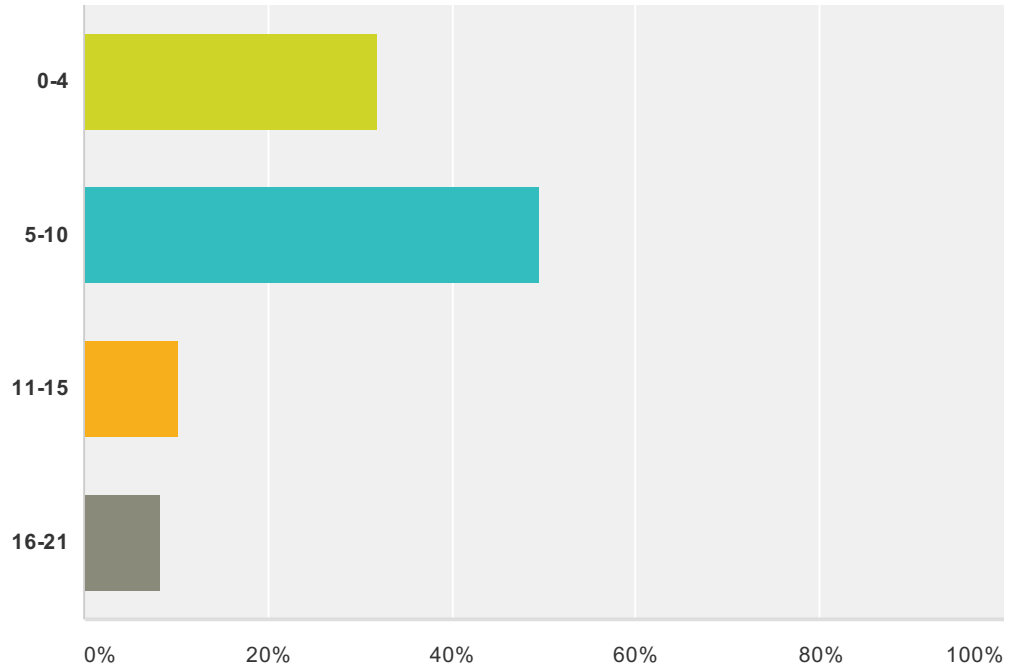

### Q10 How many of the 21 exhibitor booths did you visit?

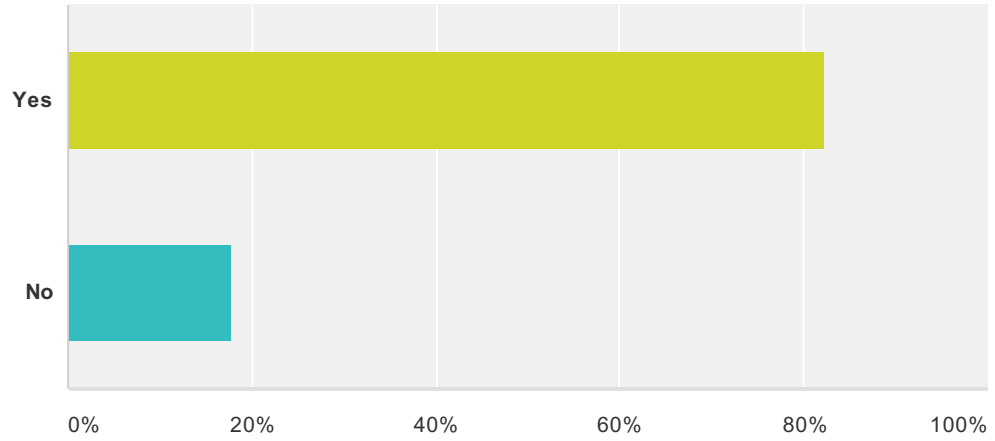

### Q11 Did you have enough time to visit the exhibits?

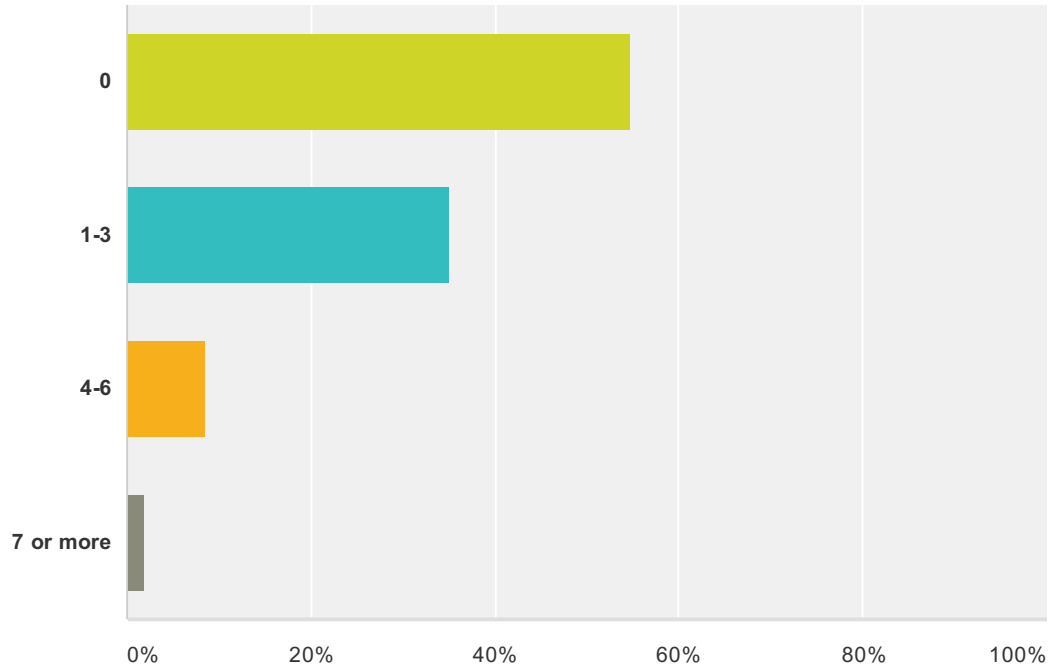

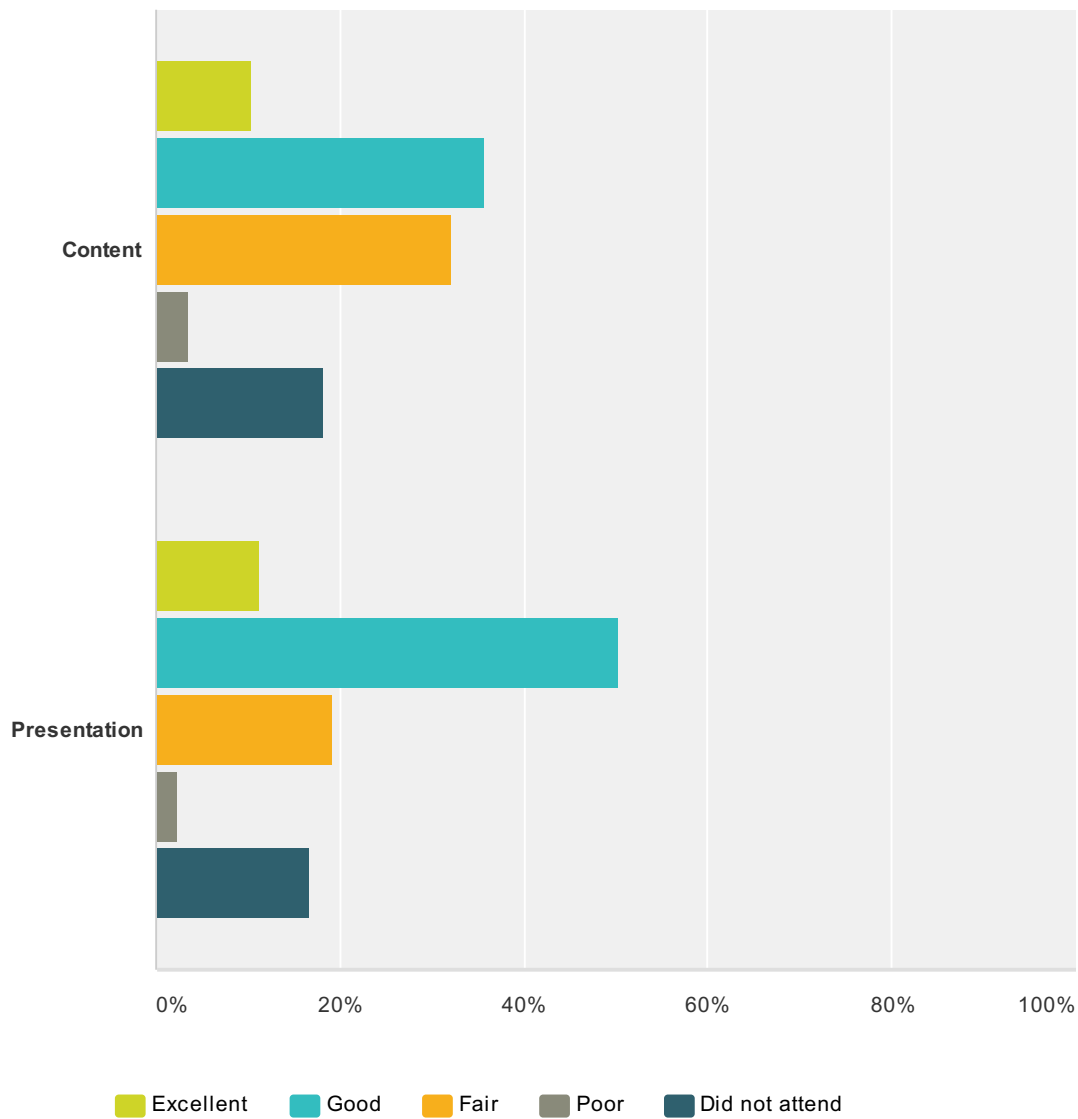

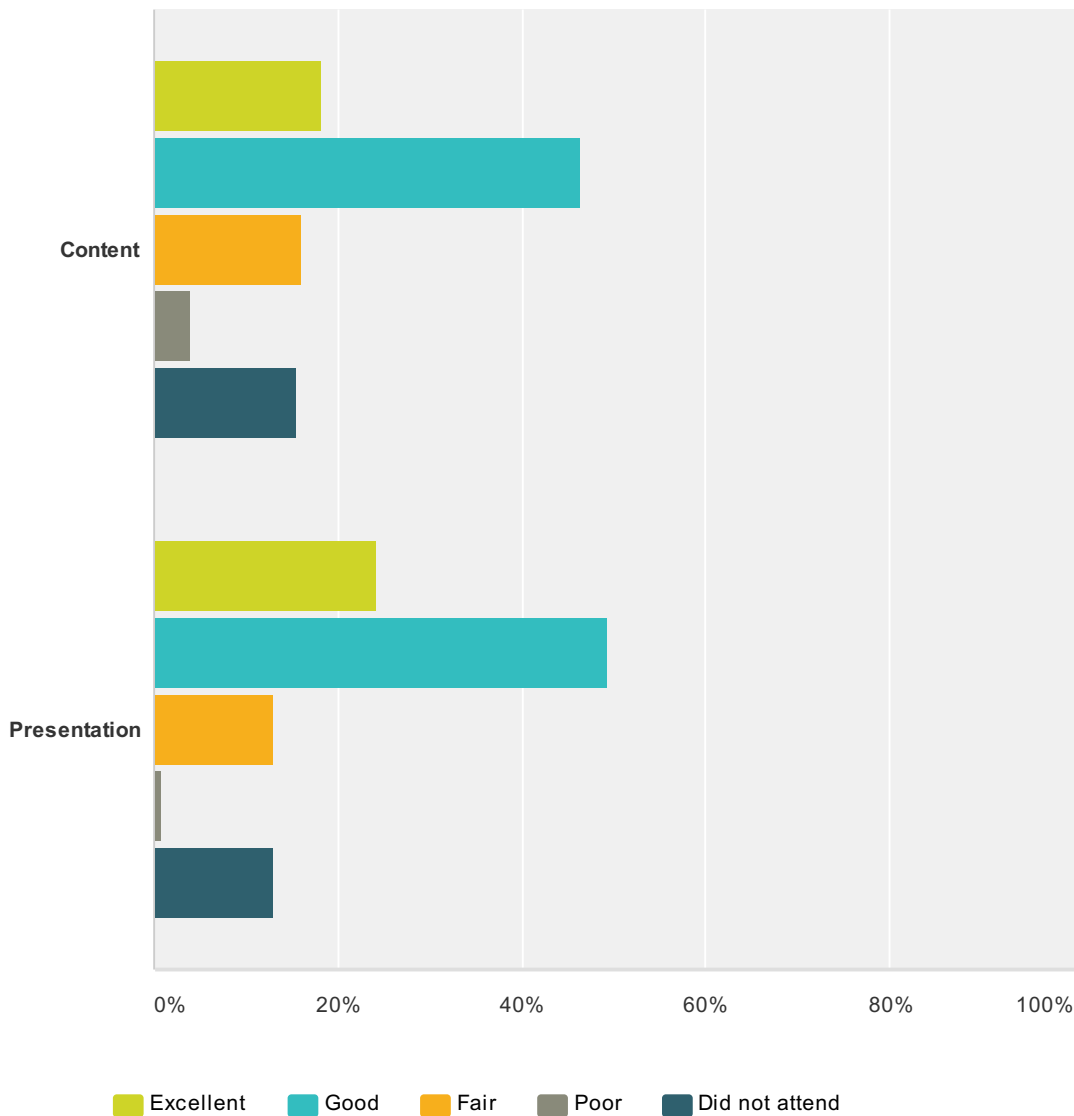

**Q16 How do you rate the ODCC presentation by Brian Maloney on Wednesday afternoon? (not considering the voting machines issues)**

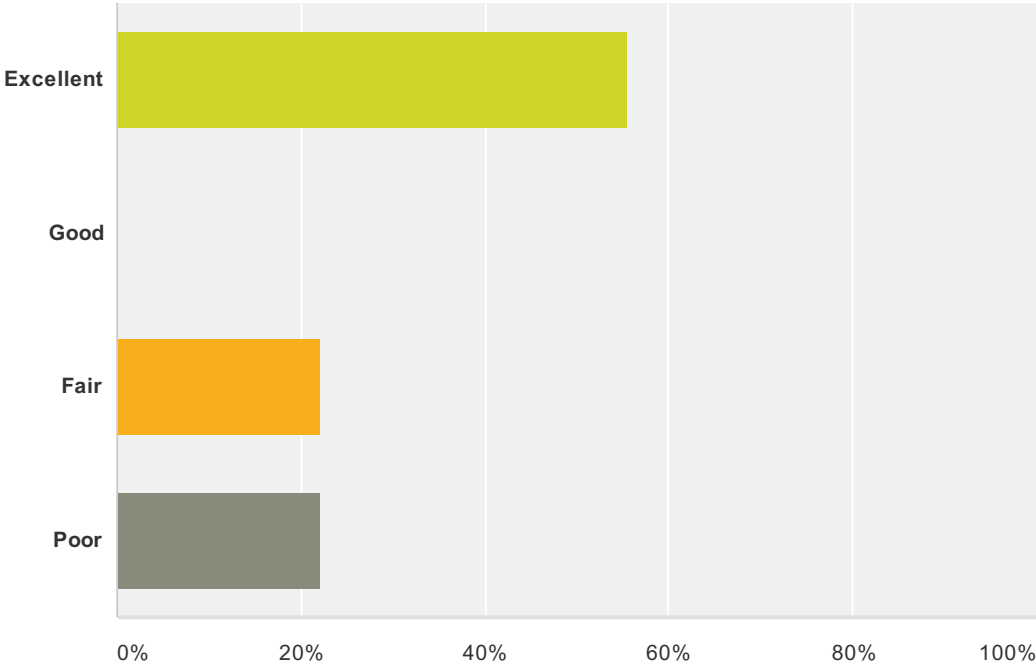

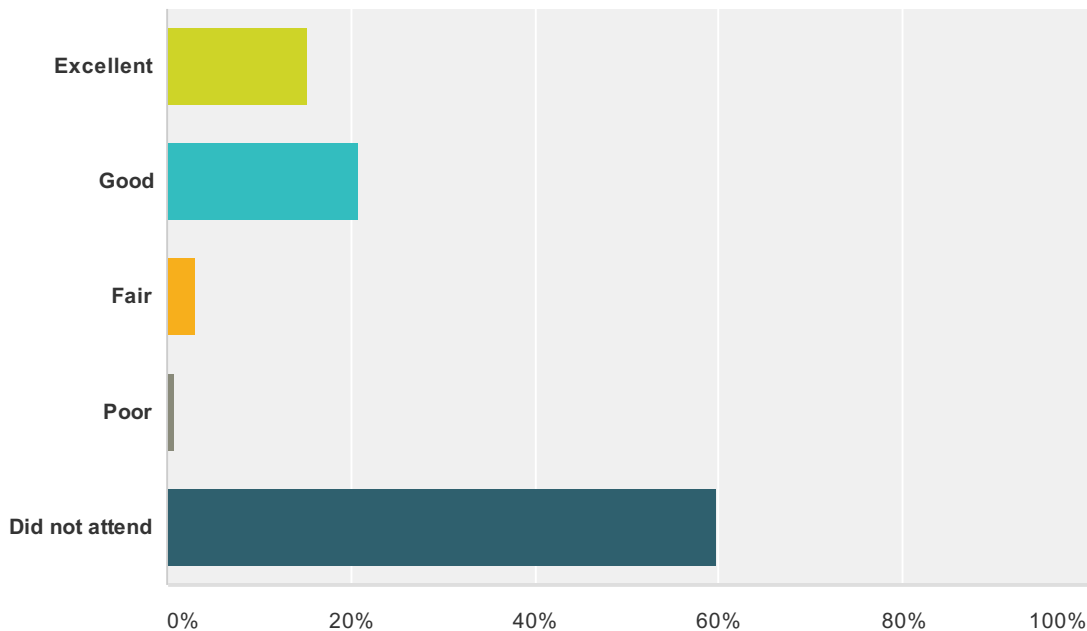

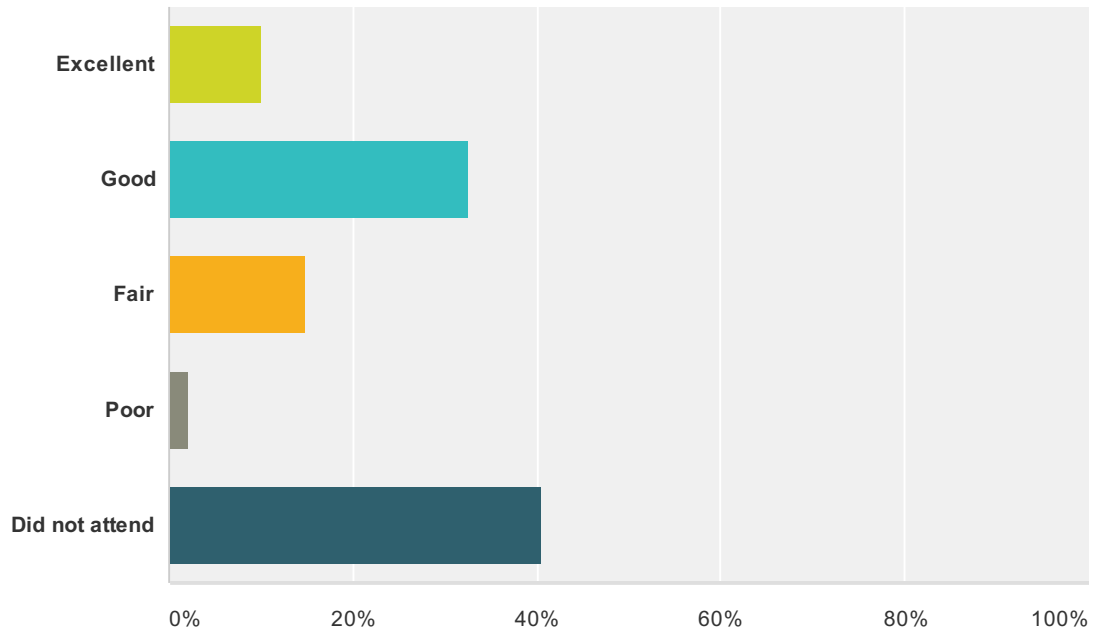

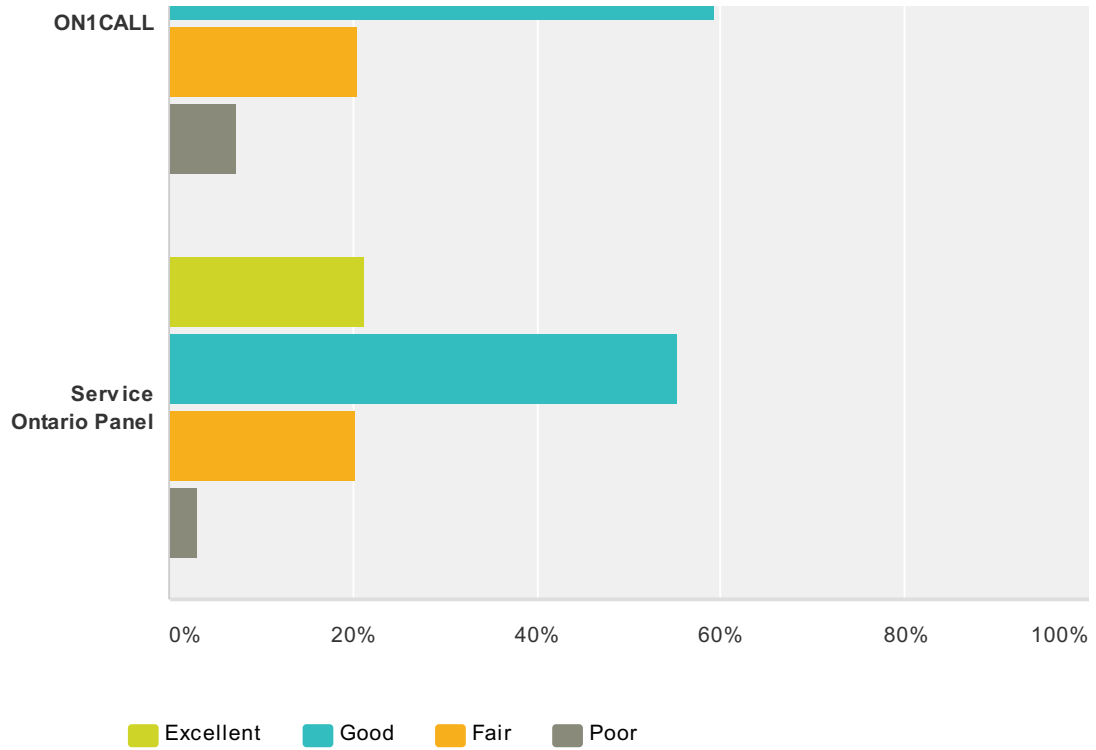


**Q22 How do you rate the concurrent sessions on Thursday? (please rate the ones you attended)**

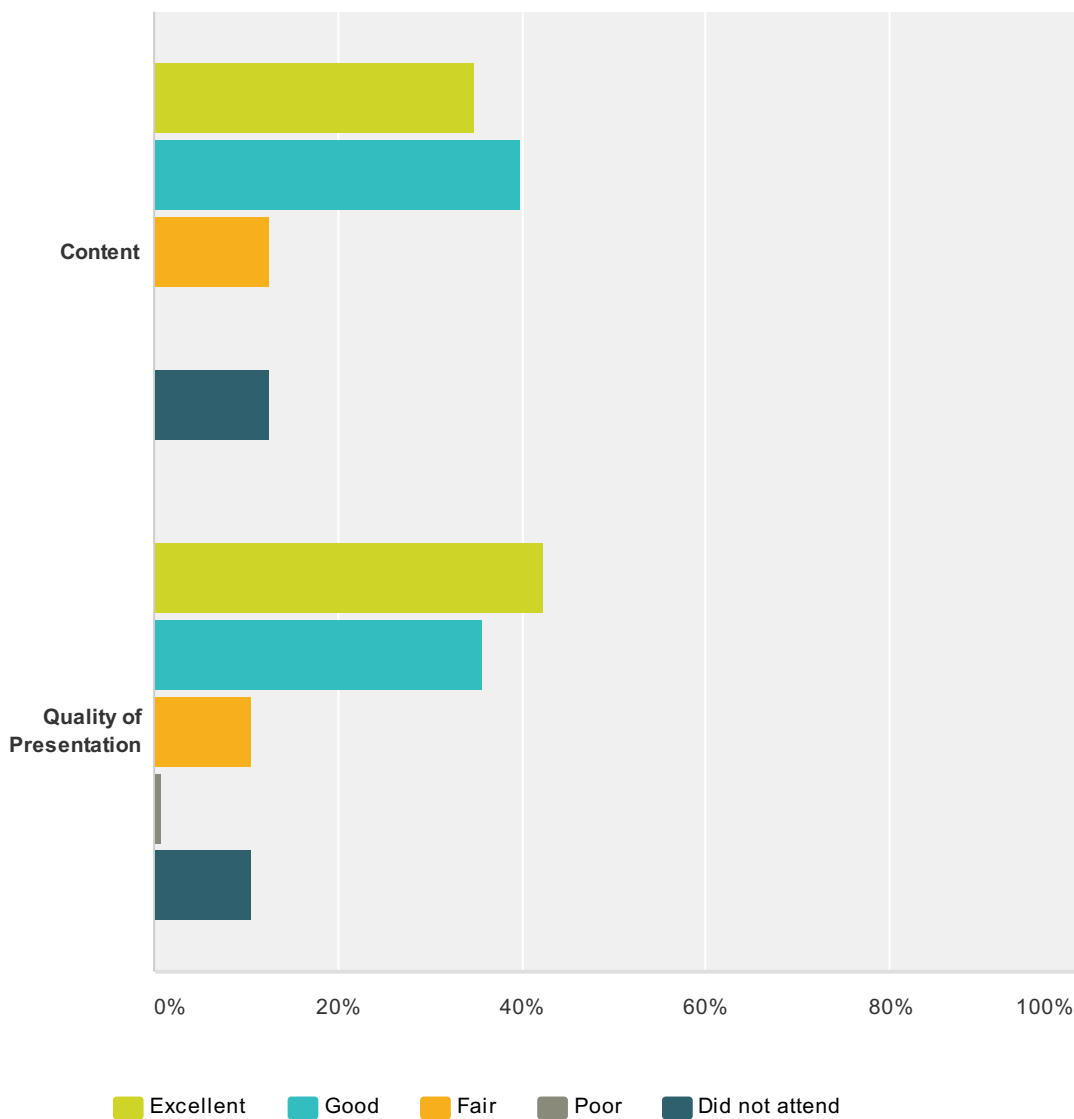

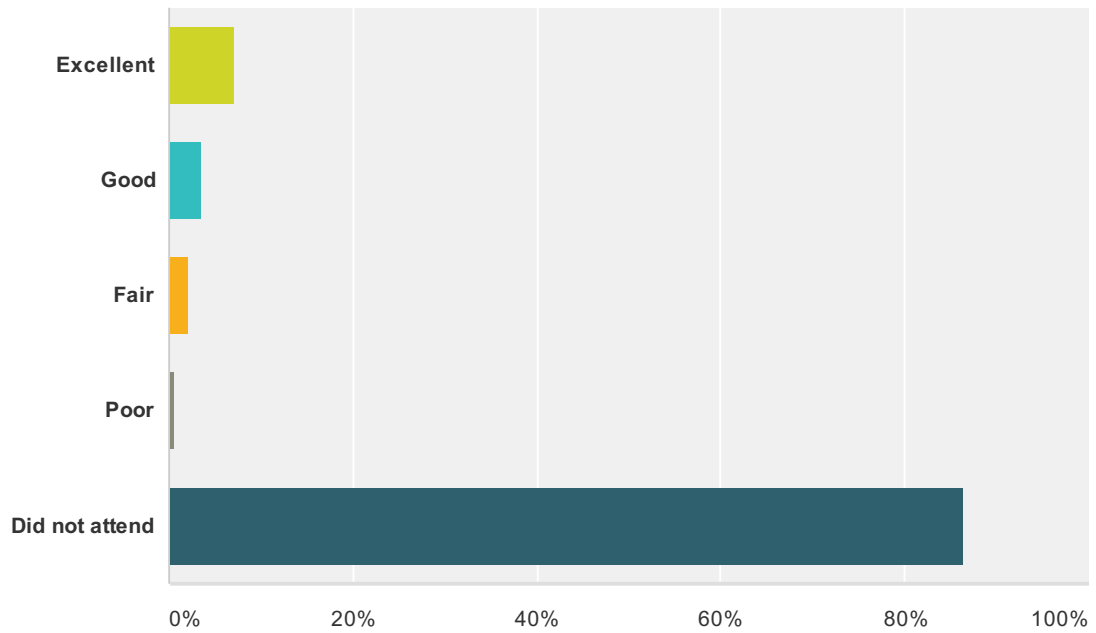

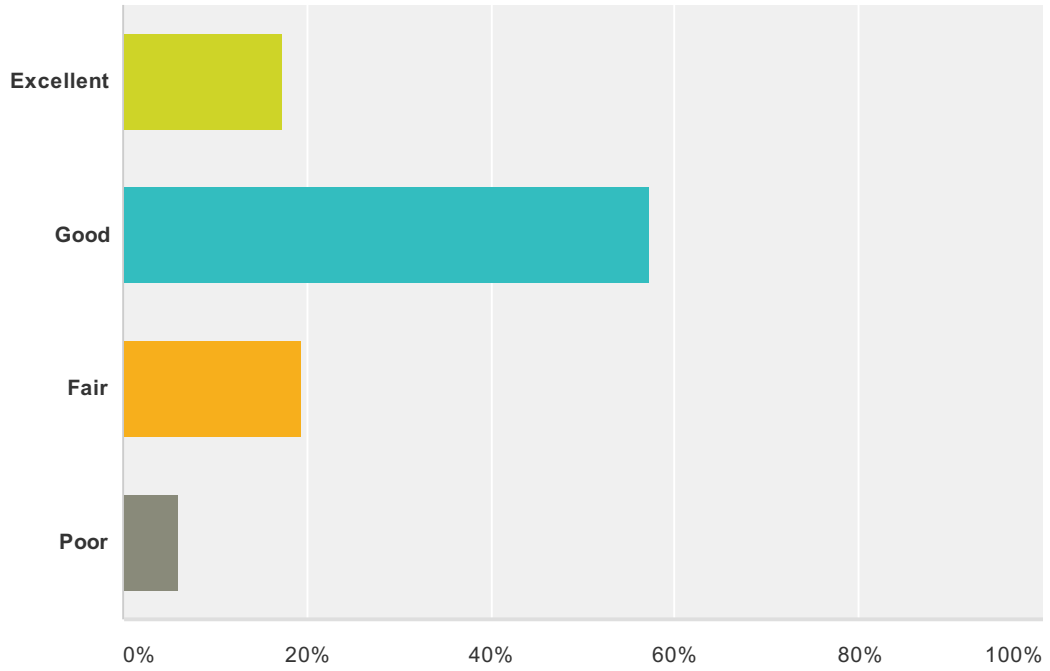

### Q25 How would you rate the value of the Open Forum discussion on Friday?

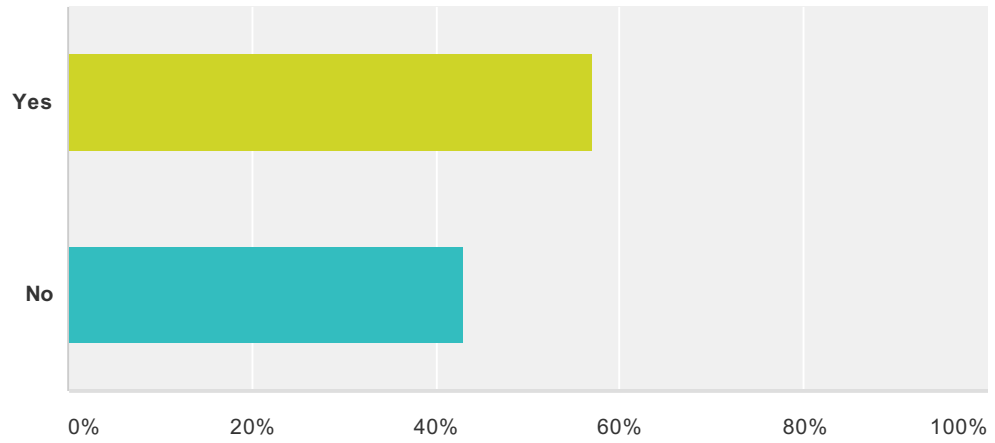

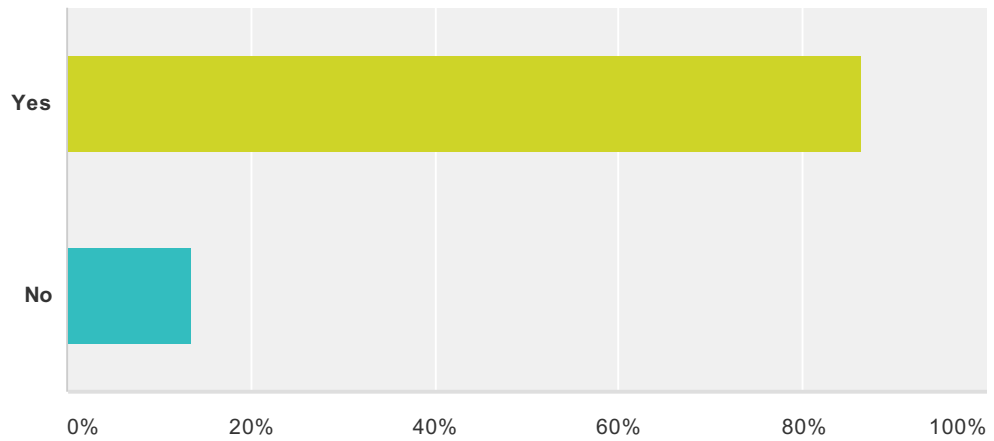

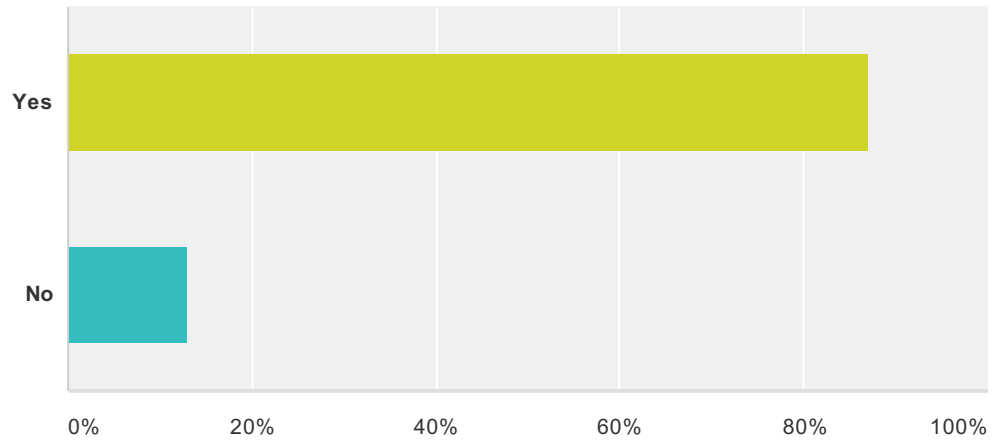

### Q30 Did you find the voting machines easy to use?

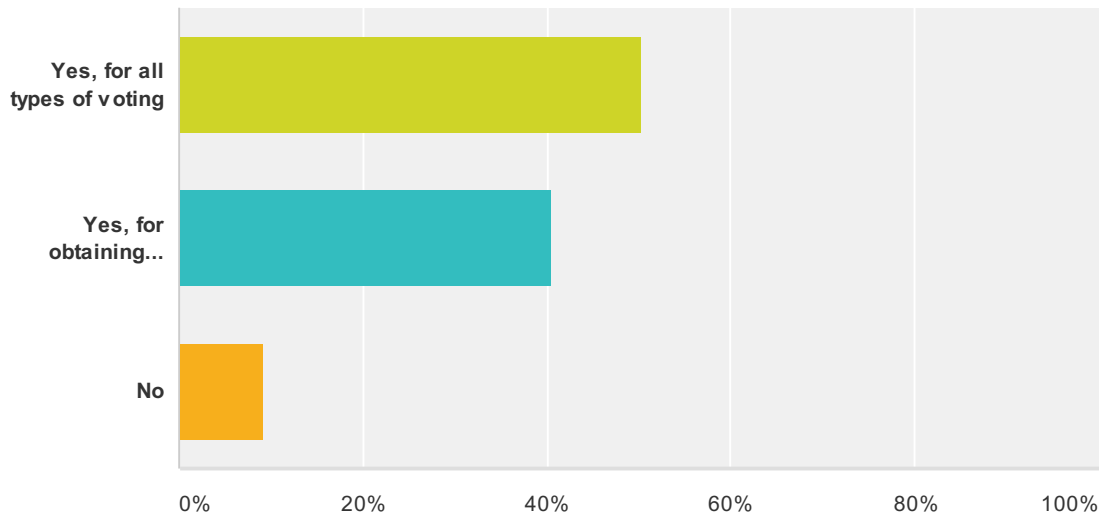

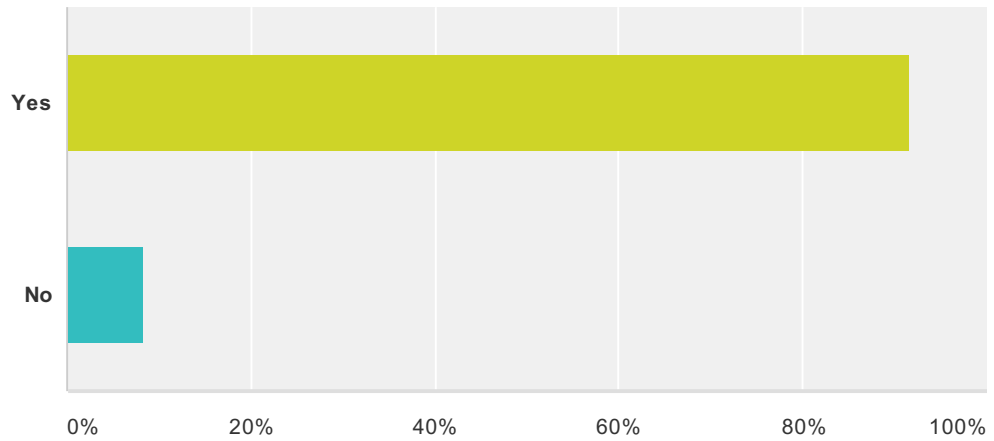

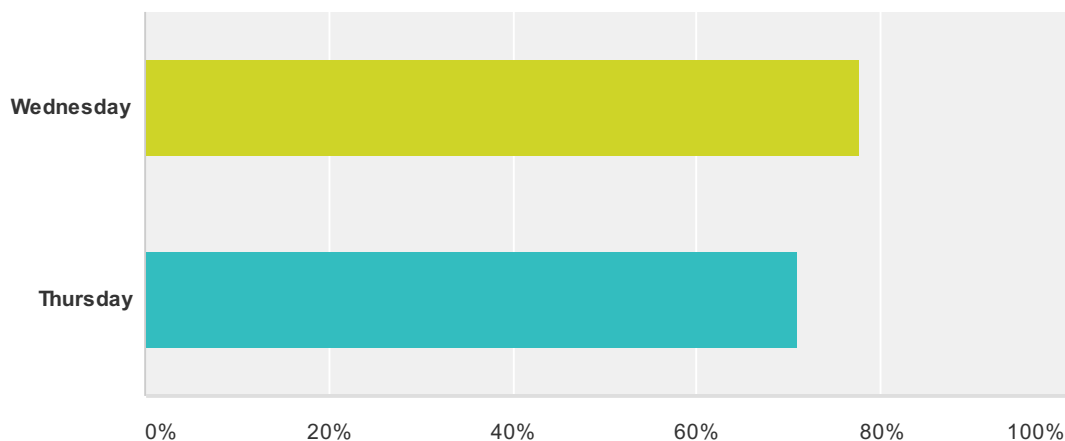
