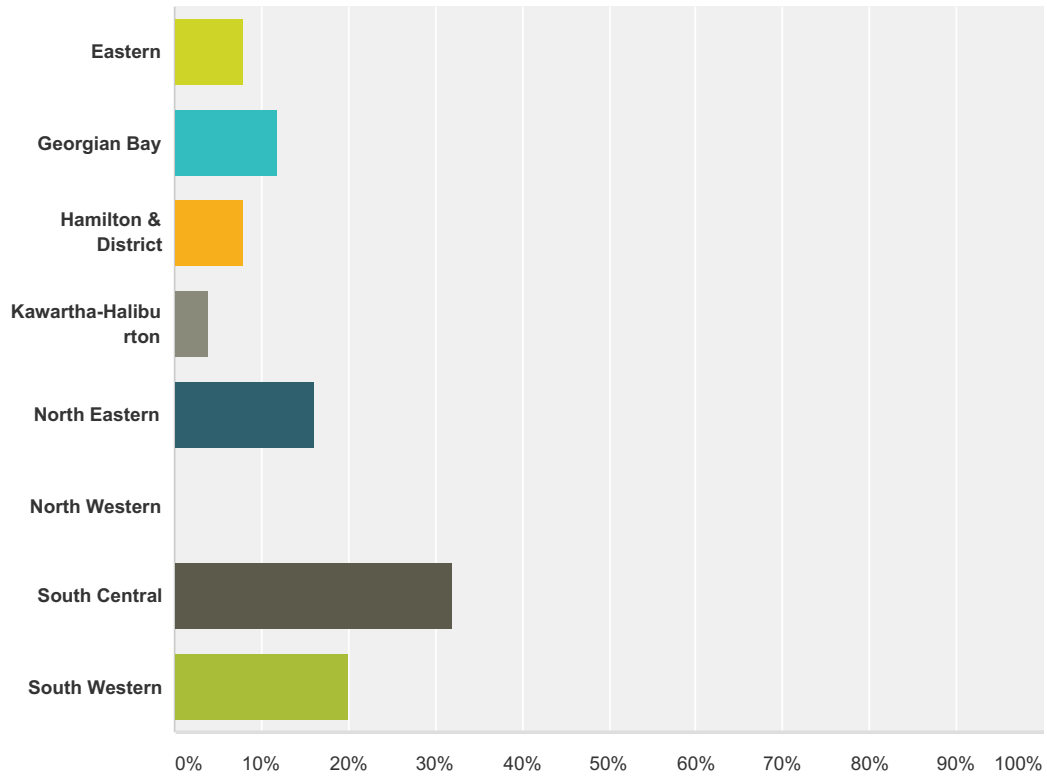


### Q1 What is your Regional Group?

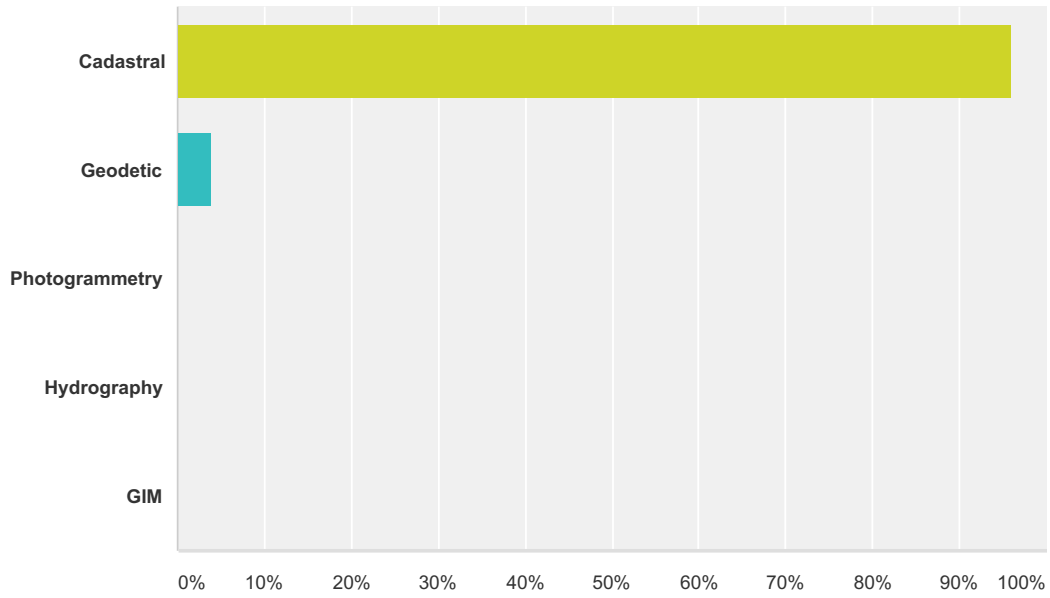

**Q2 Please indicate which branch of the association you belong to:**

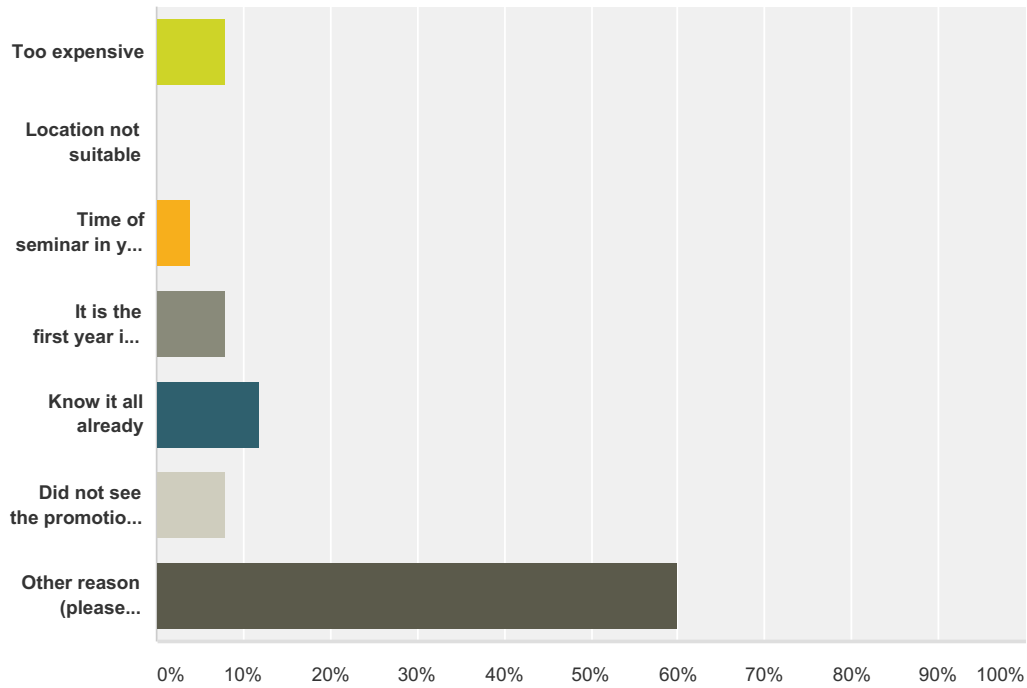
