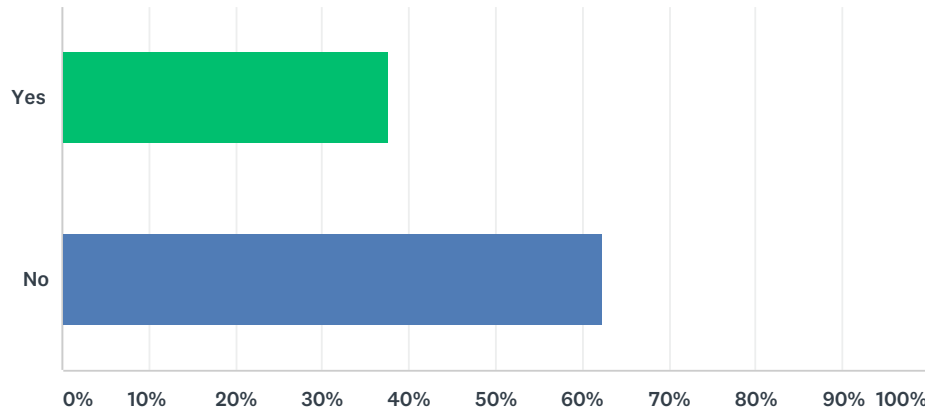


Q1 Are you aware of the Special Provision under the General Conditions?

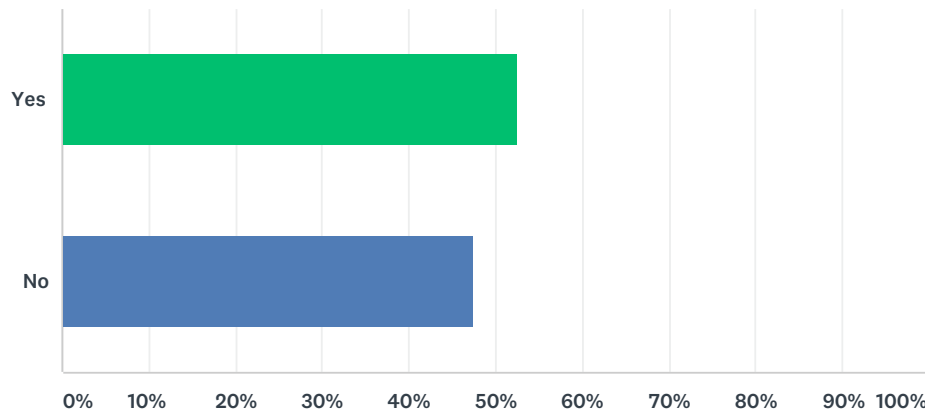

Q2 Are municipalities still completing Assumption Surveys at the maturity of the development process?

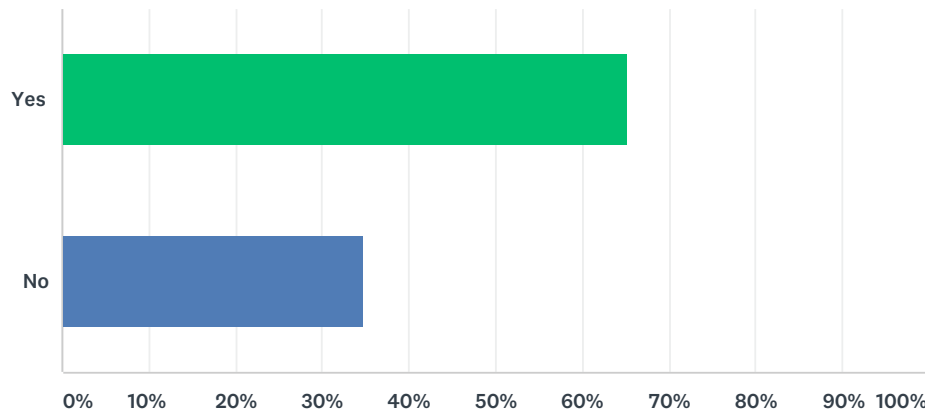

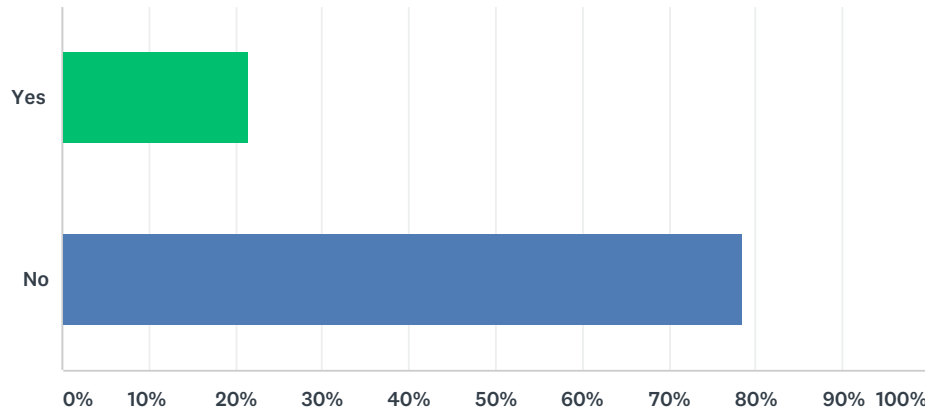

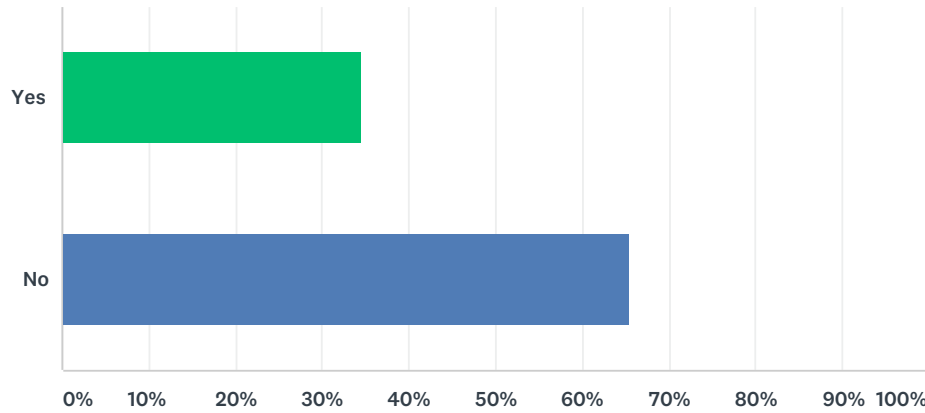
